I. Moment of Silent Prayer or Silence: Andrea Thomas

II. Call Meeting to Order: Andrea

III. Reading of the Minutes from May 1, 2025: Ronnie

A. Beverly asked that today's meeting be recorded. Khim recorded meeting.

IV. Presentation on Financial Matters: Khim

A. Banking Updates of balances, credits, and debits were given.

- V. NR's Email to the Board, Dated 6 11 25: Andrea
 - A. The Board must respond to NR's email before tomorrow, 6 13 25 due to NR attending a court hearing for a delinquent resident on the 13th. The Board sent an email to verify certain information needed for the hearing.
- VI. Estimate for Repair of Wet Pond Fence: Andrea/Khim
 - A. The original estimate was \$650.00 which included replacement of rails and posts including concrete for the post installation.
 - B. Six of seven Board members objected to the use of concrete and requested that the vendor does not use concrete. It was noted by one member that concrete has been used in recent repairs by vendors.
 - C. Vendor will be asked not to use concrete; a revised estimate will be requested from vendor.
- VII. Emailed Invoice/Letters from Chad Toms (lawyer): Andrea/Khim
 - A. Chad Toms hosted meeting with the DOJ and Councilwoman Hansen to advise communities on BOI mandates from the U.S. Treasury Dept.
 - B. Chad Toms charged York Farms for advice that he gave after the meeting. The Board believes that it was not made clear that additional advice would be at a cost to be paid by York Farms.
 - C. The Board agreed that the invoice amount of \$157.57 should be paid to avoid action by Chad Toms and his firm.
- VIII. Payment to JC Lawncare for Service on May 19, 2025: Andrea/ Khim
 - A. Khim will request an invoice and pay the amount of \$250.00 for the cut in May.

- IX. Updates on Delinquencies from New Castle Treasury, and Neighborhood Resources' Updates on Court Cases for Delinquencies: Andrea/Khim
 - A. One delinquent resident agreed to a payment plan presented by NR.
 - B. Most cases have been placed in common pleas court for hearings.
 - C. The total number of delinquent residents is twenty-six.
 - D. Twelve owe \$175, nine owe \$200 to \$500, four owe \$2,000 to \$4,440, and one owes \$30.00.
- X. Neighborhood Resources Will Initiate Collection Activity, Sooner: Andrea/Khim A. Due to the increasing late payments or no payments at all, the Board agreed to have Neighborhood Resource start collection action once an account is 60 days late. Initially, NR waited one full year before collection action started.
